

**MINUTES
CITY OF HARTFORD
JUNE 18, 2018**

The City Council of the City of Hartford, Alabama, met in the conference room in city hall at 6:00 p.m. on June 18, 2018. The following members were present: Mayor Jeff Sorrells, Jo Ann Lindsey, Bobby Burks, Ken Hales, and Wendel Nolen. Absent: Paul Fondren.

Others in attendance: Vicky Marsh, Annie Ward, Dennis Dorriety, Jason Eubanks, Vernon Alford, Sara Hodge, Randall Baker and Michael Pollard.

Mayor Sorrells called the meeting to order and opened with prayer followed by the Pledge of Allegiance.

With the council having read the minutes from the regular meeting of June 4, 2018, Mayor Sorrells asked the wishes of the council. Councilmember Lindsey moved to approve the minutes of June 4, 2018, which motion was seconded by Councilmember Hales. The council voted unanimously in favor thereof.

AGENDA:

1. **GARBAGE CART DEADLINE** – Mayor Sorrells advised a deadline needs to be set for picking up a garbage cart. At this time there are about 57 cans remaining to be pickup. Mayor Sorrells suggested hanging door hangers after Fourth of July week.
2. **STREET SWEEPER** – A proposal setting forth the terms of the lease-purchase financing of the street sweeper was presented for approval. The term of the lease is for three years with three annual payments of \$26,641.18 and one balloon payment of \$66,853.00. Councilmember Nolen moved to approve said proposal, which motion was seconded by Councilmember Hales. The council voted unanimously in favor thereof.
3. **“BACK TO SCHOOL” SALES TAX HOLIDAY** – Resolution 06-18-18 providing for City of Hartford’s participation in the “Back to School” Sales Tax Holiday was presented for approval. Councilmember Hales moved to adopt said resolution, which motion was seconded by Councilmember Nolen. The council voted unanimously in favor thereof.

COUNCILMEMBER COMMENTS:

Mayor Sorrells

- Mayor Sorrells stated that the Air Performance grant is about to be finalized. Air Performance exceeded the requirements set for hiring the required personnel.
- Mayor Sorrells advised that someone is interested in painting a mural on the wall next to State Farm. He stated that the council could decide what to paint or a committee could be appointed.
