## ORDINANCE NUMBER 06-03-19 AMENDING ORDINANCE NUMBER 09-18-17-1

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HARTFORD, ALABAMA, AS FOLLOWS:

**Section 1.** That the sum of \$10.00 will be collected, in addition to all court costs and fees now or hereafter authorized by law, for conviction of any violation of municipal ordinances of Hartford, Alabama, pursuant to Section 12-14-14, Code of Alabama, 1975 as amended.

**Section 2.** The additional fees will be collected in the amount of \$33.50 for traffic violations and \$68.00 for all other misdemeanors, and paid into the Municipal Court Account which shall be used exclusively for the operations and maintenance of the Municipal Court, Magistrate supplies and expenses pursuant to Section 11-47-7.1 Code of Alabama, 1975 as amended.

Section 3. The additional fees will be collected in the amount of \$50.00 for the issuance of an alias warrant, and deposit fees that are assessed and collected into the Municipal Court Account pursuant to Section 11-47-7.1 Code of Alabama, 1975 as amended. The Municipal Court may not collect any additional fee for the issuance of a warrant of arrest or a search warrant.

**Section 4.** The additional fees will be collected in the amount of \$10.00 for the issuance of a Failure to Appear, and deposit fees that are assessed and collected into the Municipal Court Account pursuant to Section 11-47-7.1 Code of Alabama, 1975 as amended.

**Section 5.** Bail for persons with municipal ordinance violations is as determined by the Standing Order Regarding Bail and Indigency Determination as previously entered by the Municipal Court on October 5, 2015, and as maybe amended in the future.

**Section 6.** A \$35 bail bond filing fee will be collected on bonds issued by the Court. Additionally, a \$100 bail bond fee, pursuant to Section 12-19-311 Code of Alabama, 1975 as amended will be collected on all Misdemeanor cases and serious traffic offenses, except if a person is released on a judicial public bond, recognizance, or signature bond, including a bond on electronic traffic and non-traffic citations, the fee shall be affixed at \$25.

**Section 7.** The following minimum schedule of fines and court cost for traffic violations are hereby adopted by the City of Hartford, Alabama and said minimum of fines and court cost for traffic violations are as follows:

**Section 7.** That the foregoing schedule of minimum fines, court cost and all additional fees and court costs referred to in Sections 1, 2, 3, and 4, are the aggregate minimum amount of fines and court costs to be assessed for traffic violations and shall not prelude the Judge and Court from imposing a greater amount as allowed by law.

**Section 8.** The following minimum schedule of fines and court cost for non-traffic violations are hereby adopted by the City of Hartford, Alabama, and said minimum of fines and court cost for non-traffic violations are as follows:

That the foregoing schedule of minimum fines, court cost and all additional Section 9. fees and court costs referred to in Sections 1, 2, 3, 4 and 6 are the aggregate minimum amount of fines and court costs to be assessed for non-traffic violations and shall not preclude the Judge and Court from imposing a greater amount as allowed by law.

The provisions of this Ordinance are cumulative and shall not be construed Section 10. to repeal or supersede and laws not inconsistent herewith.

If any part of this Ordinance is declared invalid or unconstitutional such Section 11. declaration shall not affect the parts of which remain.

Section 12. This Ordinance shall become effective upon its adoption and publication.
